### APPLICATION RECOMMENDATIONS

Apply **VERDE-CAL K PLUS** monthly or bi-weekly.

For continued optimal growing conditions, apply **VERDE-CAL K PLUS** at 5 pounds per 1,000 ft<sup>2</sup> or 220 pounds per acre (250 kg/ha) monthly through the growing season, or as needed. Soil test recommendations should be followed.

When applying bi-weekly, apply **VERDE-CAL K PLUS** at 4 pounds per 1,000 ft<sup>2</sup> or 174 pounds per acre (195 kg/ha) every two weeks throughout the growing season.
